



Cheshire Phoenix Wheelchair Basketball Club. **Parent / Guardian Membership agreement and Code of** **Conduct 2018/2019**

The Cheshire Phoenix Wheelchair Basketball Club has a high profile and we must all be seen by sponsors and members of the public to be setting an example and behaving professionally.

As Parents / Guardians you must be clear on the rules of the club both for yourselves and for your son/daughter/ward or any young people you bring to the sessions with you.

By signing your membership letter you and your son/daughter/ward etc are agreeing to abide by the rules outlined in the Club Documents and Policies.

Through signing the Membership letter and paying a subscription your son/daughter will become a Junior (under 18 at midnight on 31st August 2018) Member of the Cheshire Phoenix Wheelchair Basketball Club (Phoenix WBC)

I agree:

- To ensure he / she attends every training session and match unless there is a valid reason. I also agree to contact the Club Coach if my son/ daughter is unable to attend with as much notice as possible.
- To ensure he / she is dressed appropriately (no jeans, no t-shirts with inappropriate logos/writing on, no short tops or t-shirts)
- To ensure he/she always attends training with a non-fizzy drink in a plastic bottle and any necessary food.
- I am fully committed to working with members of the Committee to achieve the aims and objectives of the club.
- I will read the BWB and club Child Protection policy and help to promote a safe environment for all Children at the club.
- I will support and respect decisions made by the Club Committee,
- I will respect and show consideration to the mental and physical wellbeing of fellow club members, including abiding by the club equal opportunities policy,
- To remember that Children are involved in sport for their enjoyment – not yours.
- If I have any grievances, complaints or disciplinary issues within the club, I will take them to the Club Committee,
- No junior player under the age of 18 is permitted to consume alcohol when on club activities / events. Also no junior player under 18 is allowed to Smoke at any club activities / events.

- The use of any banned substance as identified by the World Anti Doping Agency is prohibited. (see Club Coach for more information)
- I agree to pay the relevant fees for training and matches, and understand that not paying subscription fees and or training fees may affect my son/daughter's membership of the club and may result in disciplinary procedures being taken.
- I agree that my son/daughter will behave appropriately and within the rules during matches.
- I also agree that as Parent/Guardian I will behave appropriately and within the rules at training and at matches and accept the decisions of all officials and club officers.
- To collect my son/daughter at the times designated - eg training, matches, events. Please check collection times when dropping your child off at the event. If you do not contact us we will attempt to contact you for 15 minutes, following that we will contact the emergency contacts you gave us in your son/daughter's medical form. If after one hour we have been unable to contact anyone and have not heard from you we will have to contact the relevant authorities (eg Police, Social Services)
- That I will ensure the training session/ match / event is on before I drop my child off – I will not just drop them in the car park. (please note the club will do everything possible to ensure you are made aware of any changes in timings etc but it is your responsibility to check prior to leaving the venue)

Please note that the club are not able to carry out Manual Handling or Personal Care for any players including taking to toilet or changing – so please ensure that a Parent/Guardian or Carer remain at the venue at all times during training and games if they are likely to need assistance.
